Session 1: Understanding Deficits & IRS Pass-Through Decision


In March of 2012, IRTA wrote a Deficit Advisory Memo titled "Guidelines & Recommendations For Barter Exchange Deficits," but few completely understand what the Deficit Advisory Memo really means. This seminar will review the basis for the Advisory Memo and the rationales for its formation.

Further discussion will focus on the status of IRTA's request for a Private Letter Ruling from the IRS seeking an opinion that pass-through entities, like UC, do not have to issue1099B's because it represents a duplicate reporting of the same transaction.
